The Project

The e-SOHECA project is implemented within the framework of the INTERREG V-A Greece - Bulgaria 2014 - 2020 Cross-border Programme by the Municipalities of Nestos, Topeiros and Zlatograd.

The main objective of the project is the creation of an Electronic Social Care and Welfare System, which will be accessible to all citizens of the cooperating Municipalities. At the same time, equipment and maintenance work will be carried out to upgrade Regional Medical Centres in the relevent areas.

The main objective of the project is the development of an Electronic Medical Record for those citizens who wish to have it, as well as access to basic medical measurements..

In addition, equipment will be piloted to specific vulnerable groups of citizens who are far from Medical Centres to take measurements, which can be recorded directly in the system. The information can be sent to the medical staff monitoring the patient in question, while emergency alerts can be sent.
